## The Rittenhouse Renewal Giveaway

### Terms and Conditions

- 1. Eligibility:** The Rittenhouse Hotel giveaway is open to entrants who are at least eighteen (18) years old at the time of entry. Customers in cities, states, or countries that prohibit such contests are not eligible to win. Void where prohibited. These Official Rules apply to all entries. Employees of The Rittenhouse, Hersha Hospitality, and any of their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state, provincial, and local laws and regulations. Participants may enter once. No purchase is necessary to enter and win this giveaway.

- 7. Winner Requirements:** The winner will be notified by email or phone. The winner will be notified on or before July 6th, 2018. Each potential winner (parent/legal guardian if a minor in his/her place of residence) will be required to execute and return to Administrator, within five (5) days of the date notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release (if winner is U.S. resident) or a Declaration of Compliance (if winner is a Canadian resident) in order to claim his/her prize or other required documentation if outside the US and Canada. If a potential winner cannot be contacted within one week, fails to execute and return the Affidavit or Declaration within the required time period, or does not comply with these Official Rules, potential winner forfeits the prize.
